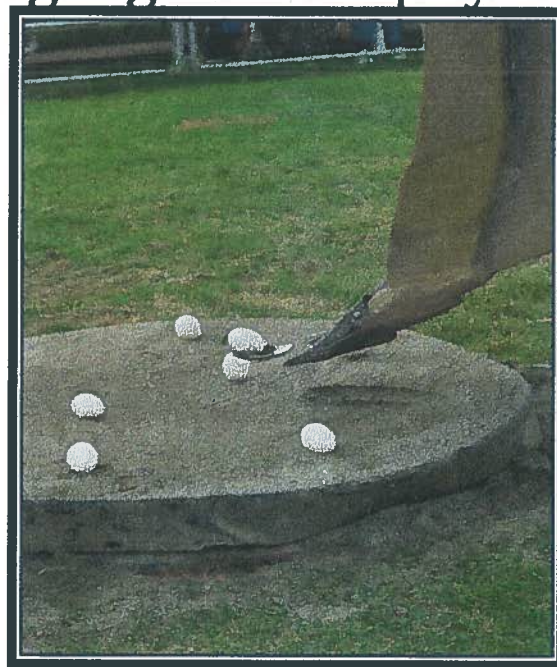

These rules have been devised for your safety and in the interest of fair play. Your cooperation in making this event a continued success by reading and following these rules is greatly appreciated.

1. To participate, entrants must complete and mail or bring entry form to: Events – Alaska State Fair, Events Department, 2075 Glenn Hwy., Palmer, AK 99645 or fax to: 907-746-7154. Please include your entry fee of \$20. Checks are made payable to the Alaska State Fair. Deadline for entry is Friday, August 20th, 2010. Late entries are accepted on a cash/check only, space available, basis, \$5.00 late fee.
2. Check in from 10 am – 11 am at the Providence Corral on the day of the event.
3. You must provide proof of competency as an operator of a backhoe with three (3) years of experience.
4. Proof of competency; Applicant must attach a letter from an employer or a letter of reference from an equipment manufacturer indicating experience.
5. Please abide by the rules of the competition and obey the contest officials' instructions.
6. Please abide by safety rules.
7. Only those contestants that have registered for the competition will be allowed to participate, there will be NO SUBSTITUTES for any contestant.
8. A panel of four (4) judges will oversee the competition and their decisions will be final. If any questions or discrepancies arise that are not covered in the rules, the panel of judges will make a decision that will be final. There shall not be any liability to the Alaska State Fair or any other sponsor for any entry, decision or award which is or may be deemed irregular in any manner.
9. If there are mechanical problems with the backhoe during the competition, that contestant may be allowed to start over.
10. All competitors should conduct themselves as professionals. Use of profanity will result in a ten (10) second penalty. Unsportsmanlike behavior could result in disqualification.
11. The top six scores from the Prelims will move on to the Finals. Any ties for 6th place will also move on to the Finals. The accumulated time from the Preliminary events will be carried over to the Finals.
